Bill,

Enclosed is the check for the \$100,000, as promised through Segal Family Foundation.

Yesterday we met with Chelsea, Maura Pally, and Rain Henderson. I had requested an hour and a half, but Chelsea couldn't do it, so I felt pressed on time to get through the documents that I had put together for them.

I tried to explain where I was coming from, although I knew from the start that Chelsea would be resistant to the points I made on vaccination. Chelsea offered her views that guns and obesity contribute to the poor health in this country, and thought that free meals at school would help. I don't disagree on any of these points, but it's clearly more than that.

She agreed that Big Pharma created the opioid epidemic in this country, and that it's a sin that we are 4.6% of the world's population but take 80% of the world's supply of pain killers. Why is it a stretch, then, to think that Big Pharma might rush some unnecessary and potentially risky vaccines to market (with no liability for vaccine injuries), and then lobby politicians to mandate them to increase profits? I understand that herd immunity is real, but you can't force every child to take every vaccine when you already know that every vaccine is not safe for every child. Some kids are vulnerable, and there are signs to look for - like chronic ear infections, rashes/eczema, reflux/gut issues, colic, and frequent colds. When these kids get too many vaccines at once, or are vaccinated when they are sick, you're taking a big risk. I mentioned the 'strong male' father at the meeting. It's just a theory, but there's science showing that higher testosterone levels with some vaccine ingredients increase autism risk. You should do more research and be especially careful with boys, knowing that the ratio of autism diagnosis is 5 boys to 1 girl.

We've made a commitment to CHAI Uganda, and we will fulfill that agreement, but going forward, I'd like to keep the door open to discuss this issue further. It's important that you be aware of what the 'other side' is thinking.
